**Reminder: Shooting hours 8:00AM - 8:00PM**

**All members MUST wear ID badges when on the range. If you observe an infraction, be proactive and correct it. We all are ALL "Range Masters". If you see it, STOP IT.**

**Safety:** 1) Targets must be positioned such that bullets impact on range back berms.

2) When calling any firing line HOT or COLD, all shooters must be notified and respond acknowledgement to the firing line command.

3) .22 long rifle rimfire benchrest only at 50yd distance on 100yd range (no rimfire magnum allowed), and only prequalified shooters at this distance, per list posted on range.

**It remains mandatory that a face mask be worn inside the clubhouse until further notice.**

# Minutes of Board of Directors Meeting

October 28, 2020

**Meeting Opening:** The meeting was called to order by President Ruth at 7:01 pm.

**Members in Attendance:** **President** Joe Ruth, **VP/IPP** Jack Schubert, **Secretary** Paul Thielen **Treasurer** David Griffiths, **Directors** Bob Drake, Peter Gantz, Allen Keefer, Lash McCall, George Kloiber, Mike Pitsikoulis, David Caudill\* **Gun Show Chairman** Josh Bolger **Groundskeeper** Gary Coleman

Directors Bob Grimes and Lester Witman were not in attendance.

**Approval of Meeting Minutes:** Minutes of the September 16, 2020 Board meeting were presented by Pres. Ruth for approval. A motion was made, seconded and passed unanimously to approve the minutes.

**Membership:** A motion was made, seconded and passed unanimously to issue Blue Cards to prospective members John Ammon, Robert Carow, Frank Day Jr., Richard Dempsey, James Franklin Jr., Deane Hart, Larry Helmich, Eric Larson, William Miller, Herbert Nigg, Michael Phillips and Mark Stemple in order that they may to begin the onboarding process.

Having completed the Blue Card requirements, a motion was made, seconded and passed unanimously to grant Ted Floyd, Salvatore Internicola, Steven Malkowski, William Roth and Ray Swilley provisional membership.

*Provisional members are individuals who have completed the Blue Card process during the suspension of membership meetings and consequently cannot be voted in by the membership as required by the Club's By Laws. Provisional members have full membership privileges until they can be officially voted in once membership meetings resume.*

Membership Chair. Thielen announced that he will be conducting interviews with individuals applying for membership in order to satisfy the requirement for applicants to be interviewed prior to the Board approving applications.

**Treasures Report:** Treas. Griffiths reviewed the Month End Financial Summary Report for September. All rifles and ammunition the Club had for sale have sold. The Profit Loss Report for the September Show shows a gross profit of \$14,183.95.

A motion was made, seconded and passed unanimously to reclassify the office help being hired to assist Annette on an as needed basis from Contract Employee to Part Time Employee.

**Advertising Report:** Treas. Griffiths reported that attendance data containing zip code information from three previous gun shows is being analyzed to determine the best locations to display future show advertisements.

**Repairs and Maintenance:** G.K. Coleman reported that the wood on the Training Range baffles is rotten in many areas and the structural integrity is compromised. The Club's tractor needs to go in for repairs with a blown seal on the steering box. Repairs are estimated to take from one to two weeks.

**Safety Report:** No Report

**Youth Programs:** Youth Program Chair. Drake reported that 9 youngsters participated in the Beginner Youth Program on Oct 3<sup>rd</sup>. There were no attendees for the Advanced Program.

**Planning Report:** Planning Comm Chair. Kloiber reported that the topical survey of the Training Range berms and storage pile has been conducted. Options for a 14 or 16-foot-high rear berm have been considered. Removal of the rotten baffles shifts the focus to the 16-foot option. Removal of the baffles eliminates current and future maintenance needs and simplifies mowing. It is estimated that an additional 400 yards of soil will need to be purchased to construct the proposed 16-foot-high rear berm. Further discussion on the project was tabled pending firm pricing for the additional soil and transportation costs.

**Gun Show:** G.S. Chairman Bolger shared charts with the table layout and human traffic flow strategies for the January show. There are 90 tables sold to date for the November show. Additional sales are expected since reminder notices went out last week to vendors who have not yet secured a table.

**Old Business:** VP Schubert informed the Board that his attorney advises that in addition to suitability for all shooting activities at the Club our current waiver needs only to be signed one time by individuals to cover that individuals future shooting activities.

A motion was made, seconded and passed unanimously to allow Blue Card holders to participate as a member's shooting guest.

**New Business:** Pres. Ruth opened the floor for a discussion on next year's membership dues. Following several minutes of discussion, a motion was made, seconded and passed unanimously not to change membership dues for 2021.

**Meeting Adjournment:** With no further topics introduced or agenda items to cover a motion was made, seconded and passed unanimously to adjourn the meeting at 8:25 pm.

## Pistol Match

We had a great combo 25yd match with very good attendance and ideal weather. The 16 shooters included two Blue Cards. Shooting started well before 9am and was over before 10am. Our great cadre of regular shooters did all the work in an efficient manner, and the match ran on auto pilot due to the A-team of helpers. Gary Coleman did some submerged grass mowing and the range was in great shape. Diana Eyman did her usual super job on photo and score keeping. Allen Keefer kept the firing line organized with all barrels pointed downrange, and we did not have to use the first aid kit! The Blue Cards were advised that any bullet wounds inflicted on the staff were a no-no and would be reflected adversely on their blue cards. 😊

The Musick clan had four shooters and one coach. The Gantz clan had four shooters and it looked like a Grizzly Adams look-a-like competition with all the beards. The entire Clark clan participated as well with great results.

The October Match was postal format paper pin and paper silhouette, both 20 rounds in five minutes. Shooters did well in all categories, and ten awards were given out for the first time in eight months.

The November 14th match will be postal format 25yd combo of 200 bullseye and 400 bullseye. The 200 bullseye involves firing 20 rounds in five minutes at B8 target. The 400 bullseye involves firing 10 rounds each at four separate B16 slow fire targets, 40 rounds in ten minutes.
